I am accredited by IMI (International Mediation Institute); I am the Founding President of Mediation Studio, an association for training in mediation through role-playing; I participated in the creation of the Espace d'Accès à la Médiation within Droit d'Urgence; I am part of the Mediation Academy, a multidisciplinary working group on the development of alternative dispute resolution methods.

I regularly participate in workshops with Gary Friedman, from The Center for Understanding in Conflict, in the US and/or in France.

My CV, although atypical, has a common thread: an intermediary role between parties and the pursuit of understanding their aspirations to enable a fruitful encounter:

- between an author and the public;
- between an author and the media;
- between an investor and market requirements;

• between parties in mediation.

My theatrical past left me with a passion for language and taught me, in apprehending each role, to ask three questions: who is the Other, where do they come from and what do they want? Empathy to grasp a role is paramount, just as for entering mediation/negotiation.

My time in the publishing world, more testimonials than literature, confirmed for me the liberating role of speech.

I would add that privately, I had discovered with passion, through many educational books, the principle of active listening.

All this naturally led me to become interested in mediation, which seemed to bring these ideas to life.

Omer Shapira

Dr. Omer Shapira (LL.B., 1992, University of Manchester, UK; LL.M., 2000, Tel-Aviv University; PhD, 2004, Bar-Ilan University) is a Senior lecturer at the Faculty of Law, Ono Academic College, Israel, and a mediator. He teaches courses and seminars on law, ADR, mediation, and mediation ethics at both undergraduate and postgraduate levels, and lectures on mediation ethics in mediator training courses, professional conferences, and continuing education programs for mediators.
